I - Introduction

On the 17 day of March two thousand and twenty two, at 14 hours, the jury nominated by the CCMAR board of Directors on 14/02/2022, met for the meeting 2 of the call Ref. CCMAR/BINCGAM/06/2022. The meeting was held for the award of a Research Fellowship for a person with a Master Degree (Bolsa de Investigação não conducente à obtenção de grau académico para pessoa com Mestrado) through the project with reference **PRIMA/0011/2019**, named as "Sustainable technologies and methodologies to improve quality and extend product shelf life in the Mediterranean agro-food supply chain" funded by the Fundação para a Ciência e a Tecnologia, (FCT) through national budget and PRIMA under the following conditions. The nominated jury was composed by Professor Deborah Power, Full Professor at Algarve University and group leader at CCMAR (president of the jury), Dr. João Cardoso, researcher at CCMAR (member) and Professor Adelino Canário, Full Professor at Algarve University, President of the board of Directors of CCMAR and group leader at CCMAR (member), and had the following agenda items: admission and evaluation of applications admitted to the fellowship CCMAR/BINCGAM/06/2022.

III - Exclusion of applications

The jury analysed the applications, considering the mandatory requirements and documents, and decided to exclude one candidate (Table 1), for the following reasons:

1. Did not presented as requested for admission the complete declaration of honour, available from the application platform or provide a copy of the certificate of recognition of the Master's degree certificate with the final classification (if awarded by a Portuguese Higher Education Institution) or a copy of the certificate of recognition of the Master's degree with the conversion of the final classification to the Portuguese scale (if the degree was awarded by a foreign University)

Thus, 7 candidates were admitted to the evaluation and ranking phase (Table 2).

Evaluation criteria and respective weighting:

1. Master academic degree grade - 30%;
2. Proven experience in proteomics - 10%;
3. Proven experience in molecular biology techniques - 10%;
4. Proven experience in metagenomics – 15%
5. Experience in bioinformatics applied to proteomes and metagenomes – 10%;
6. Work experience in a scientific research laboratory - 10%;
7. Published scientific articles in the field of knowledge - 15%.

Note: The final grades in table 3 represent the average of the individual evaluation performed by each member of the jury, presented on a scale from 0 to 10

Table 4 presents the overall classification in order of rank.
