#### I - Introduction

On the sixth day of January two thousand and twenty two, at eleven hours and thirty minutes, the jury nominated by the CCMAR board of Directors on 18/10/2021, met by video-conferece for the meeting 2 of the call Ref. CCMAR/BINCGAM/12/2021. The meeting was held for the award of a Research Fellowship for a person with a Master's Degree (Bolsa de Investigação não conducente a grau académico para pessoa com mestrado) through the project with reference EXPL/BIA-ECO/1161/2021, named as "Olfactory Disruption in the Ria Formosa? Disrolf" funded by the Fundação para a Ciência e a Tecnologia, I.P./MCTES through national funding (PIDDAC). The nominated jury was composed by Dr Peter Hubbard, Coordinator of the project and researcher at CCMAR (president of the jury), Professor Teresa Modesto, Professor at UALG and researcher at CCMAR (Member) and Dr Zélia Velez, researcher at UALG and CCMAR (member) and had the following agenda items: admission and evaluation of applications admitted to the fellowship CCMAR/BINCGAM/12/2021.

#### **III - Exclusion of applications**

The jury analysed the applications, considering the mandatory documents, and decided to exclude three candidates (Table 1), for the following reasons:

1. Not yet having completed their Master's Degree, or

P.CH.

- 2. Only presenting a Master's degree certificate from a foreign university with a request for recognition by the Portuguese Direção-Geral do Ensino Superior (DGES) but without a declaration of honour with grade, or
- 3. Only presenting a Master's degree certificate from a foreign university without recognition by the Portuguese Direção-Geral do Ensino Superior (DGES).

Thus, eleven candidates were admitted to the evaluation and ranking phase (Table 2).

#### 1) CV and experience of the candidate (70%)

#### 2) Final grade of M.Sc. (30%)

Note: The final grades in table 3 represent the average of the individual evaluation performed by each member of the jury, presented on a scale from 0 to 20, rounded to the nearest tenth.

The fellowships will be awarded to the best ranked applicant. The candidates obtained a final classification between 12.5 and 16.4 values (Table 4), with the candidate Alexandra Carvalho Alves having the highest classification (16.4 values; Table 4)

Considering the elements presented, candidate Alexandra Carvalho Alves meets the conditions for the purposes of eventual selection, so the Jury proposes the ratification of this decision to the CCMAR Board.

The Jury will proceed to the right of prior hearing of the candidates, setting a deadline of 10 working days to claim what they consider to be convenient, whether in relation to scientific or procedural matters.

With no other item on the agenda, the meeting of which these minutes were drawn up was closed, with 4 pages, and annex, which after being read and approved were signed by the members of the jury.
