I - INTRODUCTION

On the 7th day of June of two thousand and twenty two, at 11 hours and 15 minutes, the jury nominated by the CCMAR board of Directors on 01/04/2022, met, for the meeting 3 of the call Ref. CCMAR/BINCGAM/12/2022. The meeting was held for the award of a Research Fellowship for a person with a Master Degree (Bolsa de Investigação não conducente à obtenção de grau académico para pessoa com Mestrado) through the project “Aplicação de Tecnologias Inovadoras e Sustentáveis de Processamento e de Monitorização de Qualidade de Produtos Alimentares do Mar” reference MAR-01.03.01-FEAMP-0050 cofunded by the Operational Programme Mar 2020, Portugal 2020 and the European Union through the European Fund for Maritime Affairs and Fisheries.
