I - INTRODUCTION

On the 24th day of May two thousand and twenty-three, at 10:00 hours the jury nominated by the CCMAR board of Directors on 04-04-2023, met by videoconference, for the third meeting of the call Ref. CCMAR/IAD/03/2023. The meeting was held for the award of a vacancy for a Data Scientist – Investigador para Administração de Dados (M/F) under an uncertain term working contract for applicants of any nationality, including stateless candidates for temporary needs and connected activities under project ALG-05-3559-FSE-000020_RHAQ funded by Fundo Europeu de Desenvolvimento Regional (FEDER) da União Europeia, through CRESC ALGARVE 2020 do Portugal 2020. On May 22nd at 13:27 candidate Dr. Mohammad Ali Rostami has sent an email cancelling his application to the call CCMAR/IAD/03/2023. On May 23rd at 16:20 candidate Dr. Andrzej Tkacz has sent an email acknowledging the provisional results.

III - CONCLUSION

Both candidates have sent confirmation of acknowledging the provisional results.

Due to the urgency in starting the job the jury has decided to meet after the acknowledgment of the provisional results.

The candidate ranked in first place cancelled his application.

For this reason the jury unanimously decided to offer the position to candidate provisionally ranked in 2nd place Dr. Andrzej Tkacz.

In accordance with the presented elements the candidate Dr. Andrzej Tkacz meets the conditions for selection - (Table 1).
