I - INTRODUCTION

On the 17th day of April two thousand and twenty-three, at 14 hours and 30 minutes, the jury nominated by the CCMAR board of Directors on 23-01-2023, met by video conference, for the meeting 3 of the call Ref. CCMAR/IJ/01/2023. The meeting was held for the award of a Junior Researcher through the project HORIZON-CL6-2021-BIODIV-01-12: Improved science based maritime spatial planning and identification of marine protected areas, funded by Horizon Europe Framework Programme (HORIZON; HORIZON-RIA HORIZON Research and Innovation Actions). The nominated jury was composed by Doctor Jorge Assis, researcher at UALG and CCMAR, (President); Doctor Bárbara H. Costa, researcher at UALG and CCMAR (member) and Doctor Mark Costello, Project coordinator and researcher at Nord University (member), and had the following agenda items: decision about the final result following the end of the right of prior hearing of the candidates.

Concluded the period of prior hearing of the candidates there were no claims for this reason the selection committee remains unanimous with the provisional decisions taken in minute 2.


In accordance with the presented elements the candidate Ana Navarro Campoy meets the conditions for selection - (Table 1).


