# Research Fellowship – 1 vacancy

Within the project – DISROLF Project number: EXPL/BIA-ECO/1161/2021

The Centre for Marine Sciences (CCMAR) opens one (01) Research Fellowship for a person with a Master Degree (Bolsa de Investigação não conducente à obtenção de grau académico para pessoa com mestrado), for applicants of any nationality, including stateless candidates, and holders of political refugee statute, in the scientific field of **Ecological Sciences**, within the research project: **EXPL/BIA-ECO/1161/2021**, named as "Olfactory Disruption in the Ria Formosa: Disrolf" funded by the Fundação para a Ciência e a Tecnologia, I.P./MCTES through national funding (PIDDAC) under the following conditions:

## **Host and Contracting Institution: CCMAR**

This fellowship is intended for Master's Degree holders that are enrolled in a non-academic degree course, integrated in the educational project of a higher education institution and developed in association or cooperation with one or more R&D units at the starting date of the fellowship.

#### Work Plan, Tasks to perform and objectives:

The project DISROLF aims to assess possible interference of compounds released in waste-water from treatment plants on the chemical communication systems of animals in the Ria Formosa, Portugal. This will involve electrophysiological investigation of the olfactory/chemosensory systems of fish, crustaceans and molluscs, and the subsequent chemical identification of both natural and human-derived odorants.

Specifically, the fellowship holder will be involved in the following tasks and objectives:

- i. Carry out scientific research tasks in the fields of electrophysiology and analytical chemistry.
- ii. Participate in routine laboratory tasks, and wastewater sampling.
- iii. Prepare scientific articles and present the results.
- iv. Participate in the daily management of the research project.
- v. Supervising students in the final year of their bachelor degree.
- vi. Participate in scientific dissemination to the general public.

#### **Scientific Supervisor:**

Dr. Peter Hubbard, Coordinator of the project and researcher at CCMAR and Professor Teresa Modesto, Professor at UALG and researcher at CCMAR.

#### Work place:

The workplace is CCMAR (Gambelas Campus of the Algarve University, Faro, Portugal) but it might be necessary to perform some field work.

## Requirements for the application:

Applicants must meet all the conditions stated below:

- 1. M.Sc. degree in Ecology (or related discipline).
- 2. Experience in analytical chemistry and related laboratory techniques.

- 3. Publication(s) in international peer-reviewed scientific journals.
- 4. Fluency in English and/or Portuguese.
- 5. Availability to start in January, 2023.
- 6. B1 driving license
- 7. This fellowship may only be granted to those who do not exceed, with the conclusion of the present fellowship contract, an accumulated period of two years in this type of fellowship, consecutive or otherwise, to be confirmed through the candidate's CV.

## **Evaluation criteria:**

Through the analysis of the application documents the evaluation criteria for the applications and their relative weight for ranking are as follows:

- 1) CV and experience of the candidate (80%)
- 2) Publications (20%)

The selection committee reserves the right to contact and interview candidates if additional information or clarification of any curricular aspect is necessary. In case it takes place, the interview aims to evaluate in more detail the curricular items used to grade the candidate according to the list above.

In the event that no applicant has the necessary profile, the selection committee reserves the right to close the call without any recruitment. In the event that the selected person does not take up the position because of failure to comply with documentary requirements or any other reason, or later during the contract if they resign, the jury reserves the right, upon convenience and opportunity, to assign the post to the next applicant in accordance with the ranking positions based on the selectable reservation list that can be used up to 6 months of the date of the present announcement.

Fellowship conditions: The fellowship is expected to start from January 2023, and will have an initial duration of 06 months, eventually renewable for additional periods until the end of the project or for the maximum of 8 months. The fellowship must be carried out under an exclusivity regimen, according to the FCT Fellowship Regulation (RBI) and of the CCMAR fellowship regulations (see <a href="here">here</a>) based on the Portuguese law 40/2004, of 18 of August (Scientific Research Fellowship holder statutes) amended by the Decree-Law 123/2019 of 28 of August. A maintenance allowance of 1144.64€ will be paid monthly, through bank transfer, and will be updated as stipulated by the Foundation for Science and Technology (see <a href="here">here</a> https://bit.ly/2ZcxUGJ).

Application period: from 21<sup>th</sup> October to 8<sup>th</sup> November 2022 at 23:59 (Lisbon time, Portugal).

- 1. a motivation letter in Portuguese or English;
- 2. a detailed Curriculum Vitae in Portuguese or English;
- 3. the declaration of honour, available from the application platform, declaring the intention to enrol in a non-academic degree course, integrated in the educational project of a higher education institution and developed in association or cooperation with one or more R&D unit, if the candidate is selected for the position;
- 4. the email contact of up to 3 referees.
- a copy of the Master degree Certificate (if awarded by a Portuguese Higher Education Institution) or a copy of the certificate of recognition of the Master degree by a Portuguese Public Higher Education Institution or by DGES – Directorate General for Higher Education (if the degree was awarded by a foreign University).

6. the <u>complete declaration of honour</u>, available from the application platform, if they are unable at the time of application, to provide a copy of the Master degree certificate (if awarded by a Portuguese Higher Education Institution) or a copy of the certificate of recognition of the Master degree (if the degree was awarded by a foreign University), as indicated above;

Non-compliance with these documents/information determines the immediate rejection of the application.

**Results and Preliminary Hearing:** The admission and evaluation results will be communicated by email within 90 working days after the application deadline. After notification, candidates have 10 working days to contest the preliminary decision.

Candidates holding degrees awarded by a foreign university should have their degree recognized in Portugal no later than the date indicated in the communication of selection for the position. Non-compliance justifies exclusion from the procedure. Information about the recognition procedures can be obtained at any Portuguese public higher education institution or by Directorate General for Higher Education – DGES (here https://bit.ly/3afyQQU). The CCMAR board of Directors reserves the right to extend the above-mentioned period, after request from the selected applicant, and as long as it does not cause a negative impact the working plan.
