#### I – Introduction

On the fifteenth day of May two thousand twenty-three, at fourteen hours, the jury nominated by the CCMAR board of Directors on 21/03/2023, met by video conference for the third meeting of the call Ref. CCMAR/BD/06/2023. The meeting was for the hiring of a Doctoral Fellowship (Bolsa de Doutoramento) for applicants of any nationality, including stateless candidates, and holders of political refugee statute, in the scientific field of **Biological Sciences** within the research project number **541718158** - named as "LittleFish-STP - São Tome and Príncipe little fish threatened - a big opportunity to unravel this fishery resource in tropical islands." funded by Aga Khan, Network for Development and the Portuguese Foundation for Science and Technology, I.P.. The nominated jury was composed by Dr. Vânia Baptista, coordinator of the project and researcher at CCMAR (president of the jury), Professor Maria Alexandra Anica Teodósio, Vice- Rector at Algarve University, team leader and researcher at CCMAR (member), Dr. Joana Cruz, Researcher at CCMAR (member) and Dr. Pedro Morais, Researcher at CCMAR and Collaborative Laboratory for a sustainable and Smart Aquaculture (member) and had the following agenda items: decision on the final results after the end of the right of prior hearing of the candidates.

### II - Claims

The communications of the provisional results, were sent to all the candidates on 27/04/2023. During the period of prior hearing no claims were received.

### III - Conclusion

Concluded the period of prior hearing of the candidates no claims were received. The selection committee remains unanimous about the provisional decision about the final ranked classification taken and reported in minute 2, and indicated below in table 1.
