## CCMAR/TSI/05/2023

#### I - Introduction

On 22<sup>nd</sup> day of the month of June, two thousand and twenty-three, at 11:00 hours the jury nominated by the CCMAR board of Directors on 27-03-2023, met by videoconference, for the third meeting of the call Ref. CCMAR/TSI/05/2023. The meeting was held for the award of a vacancy for a Research Technical Officer (Técnico/a Superior de Investigação) (M/F) in the field of Marine Biotechnology to satisfy temporary needs under an uncertain term employment contract in order to support the work carried in the context of the research project with reference: C644915664-00000026 - PRR: Pacto Bioeconomia Azul - Vertical Algas, funded by PRR Plano de Recuperação e Resiliência.
