I - Introduction

On 26th day of the month of June, two thousand and twenty-three, at 12:30 hours t the jury nominated by the CCMAR board of Directors on 26-04-2023, met by videoconference, for the third meeting of the call Ref. CCMAR/TM/09/2023. The meeting was held for the award of a vacancy for a Multimedia Technician (Técnico de Multimédia) (M/F), to satisfy temporary needs under an uncertain term employment contract in order to support the work carried in the context of CCMAR projects.
