I - Introduction

On the nineteen day of April two thousand and twenty-two, at 09:00 hours, the jury nominated by the CCMAR board of Directors on 20/12/2021, met for the meeting 2 of the call Ref. CCMAR/BM/16/2021. The meeting was held for the award of a Master's Fellowship (Bolsa de Mestrado), through the project with reference EXPL/CTA-CLI/0612/2021, named as "INDRA - Indian monsoon and vegetation dynamics: lessons from two contrasting glacial-interglacial cycles of the Middle Pleistocene" funded by the Fundação para a Ciência e a Tecnologia, I.P./MCTES through national funding (PIDDAC). The nominated jury was composed by Dr. Dulce Oliveira, Coordinator of the project and researcher at CCMAR and IPMA (president of the jury), Dr. Filipa Naughton, researcher at CCMAR (member) and IPMA and Dr. Teresa Rodrigues, researcher at CCMAR (member) and IPMA and had the following agenda items: admission and evaluation of applications admitted to the fellowship CCMAR/BM/16/2021.

III - Exclusion of applications

The jury analysed the applications, considering the mandatory documents, and decided to exclude 10 candidates (Table 1), for the following reasons:

Rajib Kumar Saha, Danail Vasilev Pavlov, Mariana Cunha Lima Silva, Thotamunage Dilmi Upeksha Wijewardhana, Shaila Rahman Ema, Priscila Moreira Lohmann, Herminia Alonso Zaldivar, Bora Ağbulut, and Solomon Joshua Avong did not provide a copy of the acknowledgement of the request for recognition of the bachelor degree by a Portuguese Public Higher Education Institution or by DGES – Directorate General for Higher Education.

Alexandre Miguel de Amorim Pinto did not provide a copy of the Bachelor degree Certificate (if awarded by a Portuguese Higher Education Institution) or the <u>complete</u> declaration of honour, available from the application platform, for applicants that at the time of application cannot provide a copy of the bachelor degree certificate (if awarded by a Portuguese Higher Education Institution).



Thus, 3 candidates were admitted to the evaluation and ranking phase (Table 2).

IV - Evaluation of applications

The Jury evaluated the applications of the eligible candidates (Table 2) and applied the classification criteria and weighting factors set out in the vacancy announcement as shown in table 3 below:

Evaluation criteria and respective weighting:

- 1. Academic assessment (including bachelor's area and disciplinary specificity) (30%)
- 2. Curriculum Vitae and previous experience in a scientific research laboratory (30%)
- 3. Experience and/ or motivation in the field of study related to the work plan (30%)
- 4. Fluency in English, with good communication skills (oral and written) (10%)

Note: The final grades in table 3 represent the average of the individual evaluation performed by each member of the jury, presented on a scale from 0 to 100%.

Table 4 presents the overall classification in order of rank.
