I - Introduction

On the 9th day of November two thousand and twenty-two, at 12 hours and 10 minutes, the jury nominated by the CCMAR board of Directors on 21/09/2022, met for the meeting 2 of the call Ref. CCMAR/BINCGAM/32/2022. The meeting was held for the award of a Research Fellowhsip for a person with a master's degree (Bolsa de Investigação não conducente a grau académico para pessoa com mestrado) through the project with reference EXPL/BIA-ECO/1161/2021, named as "Olfactory Disruption in the Ria Formosa? Disrolf" funded by the Fundação para a Ciência e a Tecnologia, I.P./MCTES through national funding (PIDDAC). The nominated jury was composed by Doctor Peter Hubbard, Coordinator of the project and researcher at CCMAR (president of the jury), Professor Teresa Modesto, Professor at UALG and researcher at CCMAR (Member) and Doctor Zélia Velez, researcher at UALG and CCMAR (member) and had the following agenda items: admission and evaluation of applications admitted to the fellowship CCMAR/BINCGAM/32/2022.

II - Candidates

One application was received for the position:

III - Exclusion of applications

The jury analysed the application, considering the mandatory documents, and decided to admit the applicant.

IV - Evaluation of applications

The Jury evaluated the application documents of the eligible candidate and applied the classification criteria and weighting factors set out in the vacancy announcement as shown in table 1 below:

Evaluation criteria and respective weighting:

- 1) CV and experience of the candidate (80%)
- 2) Publications (20%)

Note: The final grade in table 1 represent the average of the individual evaluation performed by each member of the jury, presented on a scale from 0 to 20, rounded to the nearest tenth.

Table 2 presents the overall classification in order of rank.

With no other item on the agenda, the meeting of which these minutes were drawn up was closed, with 2 pages, and annex, which after being read and approved were signed by the members of the jury.
