I - Introduction

On 6th day of the month of May, two thousand and twenty-three, at 12:20 hours, the jury nominated by the CCMAR board of Directors on 26-04-2023, met by videoconference, for the second meeting of the call Ref. CCMAR/TM/09/2023. The meeting was held for the award of a vacancy for a Multimedia Technician (Técnico de Multimédia) (M/F), to satisfy temporary needs under an uncertain term employment contract in order to support the work carried in the context of CCMAR projects. The nominated jury was composed by Doctor Rita Abecasis, responsible for the communication department (president of the jury), Professor Jorge Martins, researcher at CCMAR and member of the board of directors (member) and Professor Ana Grenha, researcher at CCMAR and member of the board of directors (member) and had the following agenda items: admission and evaluation of the applications admitted to the position CCMAR/TM/09/2023.

III – Admission and Evaluation of applications

The 18 candidates who applied were admitted to the evaluation and ranking phase (Table 1).

The candidate Afonso de Oliveira Pereira failed to attend the interview. The remaining 2 candidates were interviewed on the 6th of June 2023.

The Jury evaluated the application documents of the eligible candidates, and applied the classification criteria and the respective weightings set out in the notice of opening of the call, as shown in table 1 below:

Considering the elements presented, the candidate **Tiago Filipe David Viegas** gathers conditions for the purposes of eventual selection so the jury proposes the ratification of this decision to the CCMAR Board.

The Jury will proceed to the right of prior hearing of the candidates, setting a deadline of 10 working days to claim what they consider to be convenient, whether in relation to scientific or procedural matters.

With no other item on the agenda, the meeting of which these minutes were drawn up was closed, with 4 pages and annex, which after being read and approved were signed by the members of the jury.
