I - Introduction

On the 6th day of the month of May, two thousand and twenty-three, at 11 hours, the jury nominated by the CCMAR board of Directors on 26-04-2023, met by videoconference, for the second meeting of the call Ref. CCMAR/TSCC/08/2023. The meeting was held for the award of a vacancy for a Science Communication Officer (Técnico/a Superior de Comunicação de Ciência) (M/F), to satisfy temporary needs under an uncertain term employment contract in order to support the work carried in the context of the following research projects: ICHTHYS, Ref.H2020-MSCA-RISE-2019-872217, OptImization of novel value CHains for fish and seafood by developing an integraTed sustainable approacH for improved qualitY, safety and waSte reduction, funded by Horizon 2020 of the European Commission; BridgingALL - Bridging university to schools by ocean science, Ref. EEA.BG.CALL5.024.2020/PT-INNOVATION-0064, funded by Mecanismo Financeiro do Espaço Económico Europeu (MFEEE 2014-2021), no âmbito da Área Programática Desenvolvimento de Negócios, Inovação e PME's do Programa Crescimento Azul, BlueForestsEducation, Ref. EEA.BG.CALL5.002.2020/ PT-INNOVATION-0073, Boosting Blue Forests Education and Capacity Building funded by Mecanismo Financeiro do Espaço Económico Europeu (MFEEE 2014-2021) within Área Programática Desenvolvimento de Negócios, Inovação e PME's do Programa Crescimento Azul and also for future projects at CCMAR. The nominated jury was composed by Doctor Rita Abecasis, responsible for the communication department (president of the jury), Professor Jorge Martins, researcher at CCMAR and member of the board of directors (member) and Professor Ana Grenha, researcher at CCMAR and member of the board of directors (member) with the following agenda item: admission and evaluation of the applications admitted to the position CCMAR/TSCC/08/2023.

III – Admission and Evaluation of applications

The jury analysed the applications, considering the mandatory documents, and decided to invalidate the applications of the following candidates, as their profile did not present the following requirement: "degree (Licenciatura/BSc) in Natural Sciences, with preference for Ocean-related sciences":

The remaining 14 candidates who applied were admitted to the evaluation and preliminary ranking phase. The Jury felt the need to interview 6 candidates to evaluate in more detail the curricular items used to grade the candidates according to the criteria:

The candidate Marta Filipa Vitorino Correia declined to be interviewed. The remaining 5 candidates were interviewed on the 6th of June 2023.

The jury evaluated the application documents of the eligible candidates, and applied the classification criteria and the respective weightings set out in the notice of opening of the call, as shown in table 1.

Criteria:

- 1. Qualifications (30%)
- 2. Work experience (40%)
- 3. Motivation letter (30%)

V - Conclusion

The candidates obtained a final classification between 85 and 22 points (Table 1), with the candidate **Ana Sofia Vieira Dias** having the highest classification (85 points; Table 2).

Considering the elements presented, the candidate **Ana Sofia Vieira Dias** gathers conditions for the purposes of eventual selection so the jury proposes the ratification of this decision to the CCMAR Board.

The Jury will proceed to the right of prior hearing of the candidates, setting a deadline of 10 working days to claim what they consider to be convenient, whether in relation to scientific or procedural matters.

With no other item on the agenda, the meeting of which these minutes were drawn up was closed, with 4 pages and annex, which after being read and approved were signed by the members of the jury.
