I - INTRODUCTION

On the 29th day of November two thousand and twenty-two, at 14:00 hours and 0 minutes, the jury nominated by the CCMAR board of Directors on 21/09/2022, met for the meeting 3 of the call Ref. CCMAR/BINCGAM/32/2022. The meeting was held for the award of a Research Fellowhsip for a person with a master's degree (Bolsa de Investigação não conducente a grau académico para pessoa com mestrado) through the project with reference EXPL/BIA-ECO/1161/2021, named as "Olfactory Disruption in the Ria Formosa?
