I - Introduction

On the 20th day of April two thousand and twenty-three, at fourteen hours the jury nominated by the CCMAR board of Directors on 27/02/2023, met by video conference, for the third meeting of the call Ref. CCMAR/BD/04/2023. The meeting was for the hiring of a Doctoral fellowship (Bolsa de Doutoramento) for the project ref. C644915664-00000026 - PRR: Pacto Bioeconomia Azul - Vertical Algas (WP 5 - subprojeto Feeds) funded by PRR - Plano de Recuperação e Resiliência. The nominated jury was composed by Doctor Sofia Engrola, coordinator of the project at CCMAR and researcher at CCMAR (president of the jury); Doctor Rita Teodósio, researcher at CCMAR (member); Doctor Cláudia Aragão researcher at UAlg/CCMAR (member); Doctor Ana Teresa Gonçalves, researcher at GreenCoLab (member) and Doctor Wilson Pinto, researcher at SPAROS Lda.
