Call for a Research Technical Officer (M/F) position, in the Fisheries area, under an uncertain term employment contract under the PARTICIPESCA project (MAR-01.03.02.FEAMP-0055 “PARTICIPESCA”) and related activities and/or similar, co-financed by the Operational Program Mar 2020, Portugal 2020, the European Union through the European Fund for Maritime Affairs and Fisheries and by the Blue Ocean Foundation.

I - Introduction

On the 13th day of January two thousand and twenty-two, at nine hours, the jury nominated by the CCMAR board of Directors met for the meeting 3 of the call Ref. CCMAR/TSI/11/2021, for the allocation of the Research Technical Officer (M/F) position in the Fisheries area. The jury, composed by Professor Doctor Jorge Gonçalves (president of the jury), Doctor Mafalda Rangel (member) and Doctor Miguel Gaspar (member) had the following points of agenda: decision about the final result following the end of the right of prior hearing of the candidates.
